

Example: The annual benefit premiums for an $\$F$ fully discrete whole life policy to (40) increase each year by 5%; the valuation rate of interest is $i^{(2)} = 0.1$.

If De Moivre's Law is assumed with $\omega = 100$, and the first year benefit premium is $\$59.87$, find the benefit reserve after the first policy year.
